RE: Annual Safety Report

The Jeanne Cleary Act requires colleges and universities that receive federal funding to disseminate a public annual security report (ASR) to employees and students every October 1<sup>st</sup> (this is separate from the Campus Safety and Security Report). This ASR must include statistics of campus crime for the preceding 3 calendar years, plus details about efforts taken to improve campus safety:

For the prior 3 calendar years (2020, 2021 and 2022) we have had ZERO campus crimes within the following four categories: Criminal Offenses, Hate Crimes, VAWA (Violence Against Women Act), and Arrests and Referrals for Disciplinary Action.

Our campus safety is enhanced by the use of cameras inside and outside the school which are on 24 hours a day/7 days a week. We are also less than one mile from the Modesto Police Department so if something were to occur we are able to get timely responses from the Modesto Police Department.

As a matter of policy in the case of any crime occurring please follow the following procedures:

1. In an extreme emergency please call 911
2. Be sure to notify any staff member of the situation
3. Follow directions/guidance from the Police and/or Staff members.

Campus Facility Security and Access:

Our building and parking lot are monitored 24 hours a day/7 days a week with cameras inside and outside. Access to the building is Tuesdays through Saturdays from 7:00am to 3:00pm; we are closed Sundays and Mondays.

Law Enforcement Authority:

In the case of an immediate emergency the Modesto Police Department has full authority to address and handle any such matters.

## Alcohol and Drug Use

This campus is alcohol and drug free – alcohol and drugs are NOT permitted on campus at any time.

## Prevention of/Response to Sexual Assault, Domestic or Dating Violence, Stalking:

In the case that ANYONE is in fear of or has been the victim of sexual assault, domestic or dating violence or stalking please let one of our Staff Members know – we are here to HELP – we can help and assist with providing counseling service centers/numbers, including filing a Police Report. We will treat any and all incidents with the utmost care, concern, confidentiality and assistance needed.

When a crime covered by the Clery Act occurs, campus officials are required to evaluate if there is a serious or ongoing threat to the campus community to determine if a timely warning needs to be issued to all staff and students.

In the event of an immediate, significant danger to the health or safety of our campus community (e.g. weather, etc.), campus officials may issue an emergency notification. This notification can include the entire campus or be limited to a specific area deemed to be at risk.
